This amended Supplementary Trust Deed is being written on 18.07.2024 by Dr. Rajan Kumar S/o Sh. Balbir Singh Resident of Kulwedri Road, Kunjpura Karnal in the State of Haryana Settler/President of Trust Known as "JAI PRAKASH GARG EDUCATIONAL TRUST SOCIETY" having its head office at R.L. College Campus, Darur, and Tehsil & Distt Karnal.

That Jai Parkash Garg Educational Trust Society is a Registered Trust, Registered wide Trust Deed No 2212/1 dated 04.09.1996 at the office of Sub Registrar, Karnal and Supplementary Trust Deed No 11324/1 dated 04.01.2006 & 11334/1 dated 28.03.2014, 8679/1 dated 18.11.2019, and 639/1 dated 02.06.2020.

That the Trust is running various educational institutions in Karnal, however it is transpired that the Trust Deed above referred to is not fulfilling the legal formalities and this deficiency is a hurdle in smooth functioning of the trust as the contents of the trust are not in speaking terms, hence it is decided by the Trustees of this trust in the meeting held on 17.07.2024 to modify the terms and conditions of the Trust Deed, by executing a supplementary Trust Deed.







RULES, REGULATIONS & BYE- LAWS OF JAI PRAKASH GARG EDUCATIONAL TRUST SOCIETY:

1. **NAME OF THE TRUST:** The name of the trust will be Jai Prakash Garg Educational Trust Society with effect from 18.07.2024. The earlier name Jai Prakash Educational Trust shall be changed to the new name "Jai Prakash Garg Educational Trust Society".

2. **REGISTERED OFFICE:** The registered office of the trust shall be at R.L Collage of Education Campus at Village Darar, Tehsil & Distt Karnal.

3. **AREA OF OPERATION:** Presently the operational area of the trust is within the State of Haryana; however it may extend its operational area in other Cities/ States of India

4. **MEMBERSHIP:** The number of the members of the trust will be restricted to Nine (9) members drawn from the public at large and will be known as General Body. However to be member one should be:

- Over 18 years of Age & Sound Mind
- Bears Good Character
- Citizen of India

A person shall cease to be the member of the trust in one or more of the following circumstances:

- Death
- Permanent Insanity
- Voluntary Resignation
- Expulsion by Majority Vote
- Sentence for involvement in any criminal offence or moral turpitude.
- Adjudicated bankrupt or insolvent
- Continuous absence from three consecutive meetings.
- Permanently leaves the area of operation.

5. **EXECUTIVE COMMITTEE OF THE TRUST:** The affairs of the Trust shall be controlled, governed and conducted by an executive committee which shall comprise of:

- Two Members duly elected from the General Body.

Note:

- The term of the Executive Committee shall be for Two Years or till the new committee is elected, whichever is later.
- Executive Committee can co-opt more members, if required
- Executive Committee can appoint a small sub- committee for carrying out affairs of the Trust.
- That the term of the President shall be for the period of two years. That the term of General Secretary, Cashier and other members shall be for the period of two years. They can be re-elected to any of the post by the Executive Committee General body of the trust.
- In case of vacancy or vacancies occurring in the trust the rest of trustees shall be entitled to appoint new trustees
- A vacancy may occur consequence of death- of the Trustee or Resignation of the trustee.
- All the trustees of office bearers of the trust can be replaced to any post by board of trustee of general body of the trust.
- Normally a trustee cannot be removed from the trust. But if case of some moral turpitude or corrupt activities, the trust may be constrained to terminate the membership of the trustee concerned through 2/3rd majority of members of the trust.
- the membership of the trust can be removed by 2/3rd majority of general body if the trustees are under bonafide belief that such trustee is not performing his/her duties in consonance with the objective of the trust.

6. AIMS & OBJECTIVES OF THE TRUST:

- To open, run continue educational and vocational institutions in hea the surroundings on the state of Haryana.
- To engage teachers, professionals, instructors and experts of good moral character to impart efficiently and economically up to date instruction/ education to the students.
- To establish maintain and run boarding house and residential accommodation for the students and those connected with the institutions.

iv) To develop healthy as well as critical attitude towards the development of mental, physical and moral upliftment to the students and those connected with the institutions so as to make them good citizens.

v) To accept donations, grants, presents and other offerings and to deal with the same for the purpose of the trust.

vi) To change tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions to be established under this deed.

vii) To provide concession in education, tuition fees etc to the needy financially weak and deserving candidate without distinction of caste, creed, race or religion.

7. MEETINGS AND QUORAMS

i) The meeting of the committee of trust will normally be held at least once in a month and the General Body will meet at least once in a year. The Executive Committee will meet once in a month. It may however meet as often as found necessary at a place, on a day and time to be fixed by the President or in his absence by the Secretary.

ii) Such meetings will be convened by the secretary through written notices.

iii) The venue and time of the meeting shall be decided by the President or in his absence by the Secretary.

iv) The Secretary will maintain full and proper minutes of the meeting and latest circulate to the trustees. The minutes shall be passed in immediate succeeding meeting. The president will thereafter sign as authentic record.

v) A part from normal meetings, emergency meeting may also be called by the president, if the need arises.

vi) In all the meetings decision by the simple majority vote of the trustees present and voting except in financial decision where $2/3^{\text{rd}}$ of the majority of the total number trustees will be necessary.

vii) To call a meeting with at least five trustees (including the President) must be present and voting.

viii) The meeting shall be presided over by the president in his absence by his nominees.

ix) If the meeting is adjourned for the want of quorum the President shall fix the date and time of the next meeting at which no quorum would be required.

x) In case of resolution of no confidence motion is passed by 2/3rd majority fresh elections shall be held within a period of one month.

xi) Every decision shall be taken by a majority vote of the members present. However a decision regarding the removal of a member from the General Body/ Executive Committee and amendment of the constitution shall be taken by 2/3rd majority of the members present in such meeting and should not be less than 50 percent of the total members.

8. ACCOUNTS/ ACCOUNTING PERIOD:

i) The funds of the trust shall be kept in the bank.

ii) That the bank accounts shall be operated by the signatures of the any two of the members of Executive Committee i.e President, General Secretary & Treasures/Cashier. However board resolution by 2/3rd majority is mandatory for closure/ change in the authorized signatories in operation of the bank account.

iii) The money of the trust will not be spend on any other purpose other than the trust.

iv) The trust will raise the funds in the form of donation from the general public as and when required.

v) The President and General Secretary shall have the power to spend the amount on the construction and maintenance of the buildings with the approval of the executive committee.

The working year/ accounting period will be the financial year i.e from April to March.

9. AUDITORS: The accounts of the Trust will be audited every year by a chartered accountant to be appointed by the Trust.

10. ELECTION: The office bearers and the members of the Executive Committee shall be elected in the annual General Body meeting after every two years and such meeting shall be presided by the President.

11. POWER OF THE GENERAL BODY:

The General Body of the trust has following powers:

- i) To remove the members from the membership of the trust, if he/she is suspended by the Executive Committee.
- ii) To elect office bearers office bearers and other members of Executive Committee after every two years.
- iii) To approve annual audited statements of accounts of the Trust.

- v) To amend the constitution.
- vi) To frame rules and regulations of the Trust.

12. POWER OF EXECUTIVE COMMITTEE:

- i) To carry on day to day work of the Trust.
- ii) To suspend a member/office bearer of the Trust for misconduct.
- iii) To arrange for the General Body and Executive Committee meeting.
- iv) To have full control on the finance of the Trust.
- v) To arrange the finance for running the Trust.
- vi) To fill up any vacancy that may occur in the Executive Committee during its tenure.
- vii) To approve the annual audited statements and get the approval of General Body.
- viii) To appoint sub-committees for carrying out the affairs of the Trust from time to time.
- ix) To appoint new member of the Trust.
- x) To appoint necessary staff to carry on the objectives of the Trust.

13. POWER OF PRESIDENT:

The president will preside over all the meeting of the trust and the executive committee. He/She shall have casting vote in case of a tie. He/She shall have control on day to day working of the trust.

14. POWER OF SECRETARY:

To carry on day to day working of the trust as decided by the Executive Committee. He/She shall carry on all correspondence on behalf of the trust. He/She shall keep record of the proceedings/resolutions of the meetings of the general body or the Executive Committee and will circulate among the members.

15. POWER OF TREASURER/ CASHIER:

He/She shall be responsible for the proper maintenance of the accounts of all receipts, expenditure and prepare balance sheet and other financial statements.

16. AMENDMENT OF CONSTITUTION:

The constitution of the trust will be amended at a special general body meeting by 2/3rd majority of the members present and eligible to vote.

17. POWER OF BORROWING:

That to arrange the finance for running the Trust and for the construction of building/ expansion of the existing building and for furniture and fixtures or to buy school vans/ buses/vehicle and for providing other facilities the Executive Committee can raise loan/borrow money in the Trust name and Trust credit or against Trust movable/immovable assets from any bank or financial institution.

18. WINDING UP OF THE TRUST:

The trust shall be wound up only at a special meeting for which requisition of 2/3rd of the members on roll shall be required.

In case of winding up of the trust, all the assets after paying the debts and liabilities will be transferred to some other Institution/ Trust having aims and objectives similar to that of the trust at or before the time of dissolution or to the Haryana State.

No member shall have any claim what so ever over the Trust Property.
